
It is understood that this secret ballot would be non-binding in the selection process. The individuals who requested the ballot hoped that "it would inform members of the University Administration and the decanal selection committee of the unencumbered opinions of faculty members of the Faculty".

Please find enclosed a ballot and two envelopes. Once you have marked your ballot, place it in the white, #10 envelope and seal it. Put that envelope into the envelope addressed to MUFA and sign your name on the back envelope flap and print your University ID # where indicated. Return this envelope either by mail or in person to the MUFA Office (Hamilton Hall 103A). When your envelope is received, your name will be checked off the list of eligible voters and the envelope containing the ballot will be deposited in a locked ballot box. Ballots must be returned to the Association by 4:30 pm on Thursday, December 18, 2008.

The ballots will be counted by the Association's auditor, Hoecht Galvin Chartered Accountants. The outcome will be reported to the MUFA members in the Faculty of Business and to the Selection Committee for the Dean of the DeGroote School of Business.
