MUFA Policy on University Elections

In any election or selection process conducted by the University, its Faculties, Schools or Departments, no member of the Executive shall make public comments or recommendations about the election or selection of one faculty member over another. Members of the Executive who privately express individual opinions about an election or selection shall take care to make clear that they do not speak on behalf of the Association or the Executive.

Dear Colleagues,

I've had a hard time getting this month's report written, but I found it helpful to compose it as a letter to you. (I'll try my best to keep it from resembling that holiday newsletter from your least favourite cousin!) There is a great deal happening at the MUFA table and at McMaster, as well as a lot of provincial and federal updates that affect our sector.

Refreshed MUFA Communications

The most exciting news is already before you: welcome to the new format of the MUFA Newsletter! Many thanks to MUFA Executive Member Liss Platt (Public Relations) and our designer Lauren Wickware (www.laurenwickware.com) for creating a modern, functional look for this publication. We hope that you enjoy it and find it useful.

Future editions of the Newsletter will also include a Member Forum, to which you are warmly invited to submit an opinion column on a topic relevant to MUFA members. We hope this will become a venue for lively discussion. (Of course, the Executive reserves final editorial prerogative on all submissions.)

I'm also excited to tell you that we have new email addresses! **Please add the** @macfaculty.ca to your address book, whitelist, or safe senders list, so that you continue to receive communications from MUFA. The @mcmaster.ca addresses will remain operational for the near future as we transition over.

Updates from the Executive

At our most recent Executive meeting, we passed a new policy that applies to members of the MUFA Executive: **MUFA Policy on University Elections**.

Because the Executive's vote on this policy was divided, I thought you would want to know some of our reasoning. The rationale for this new policy was to ensure that we serve all our members fairly. If an Executive member were to speak on the record endorsing Dr. X and opposing Dr. Y for a given position, then Dr. Y might well doubt the Executive's ability or willingness to represent Dr. Y's interests in other matters. And other members might share that doubt. In short, such an endorsement could undermine our members' trust in the Executive.

That said, the risk of this policy is that Executive members might find their freedom of expression constrained in settings like search committees or award committees. That's the rationale for the second clause: in a confidential setting where ranking candidates is part of the task at hand, an Executive member may indeed communicate a recommendation, endorsement, ranking, etc., as long as they make it clear that they do so in their role as an individual faculty member, not on behalf of MUFA or the MUFA Executive.

At the December General Meeting a Notice of Motion was issued about potential changes to MUFA's Constitution. That work is still in progress: I've received extremely helpful feedback from some former MUFA Presidents, most of whom recommended changes more gradual than I had first imagined. Please hold March 6th in your calendar for a Special General Meeting on that topic and watch your inbox for the proposed changes.

The project that has consumed the vast majority of the Executive's time this year is the revision to the Faculty Code of Conduct. A great deal has changed in the world, in the university, and in our working conditions since the current version of the Code of Conduct was last updated in 1994, and it will be valuable to reach a collegial agreement about clear standards of professional conduct for faculty members.

Of course, updating a thirty-year-old policy is not trivial, and we want to do the job justice, so the process has been lengthy and complex. Some areas where we've reached agreement in Joint Committee will be of particular interest to members:

The Code should provide baseline standards of acceptable conduct but should not be a tool for managing performance.

The Code should apply to senior administrators with faculty appointments, in addition to rank-and-file faculty members.

Assessing the conduct of the faculty is properly the jurisdiction of the faculty, so in cases where a member's direct supervisor is not a faculty member, the Decision-Maker's responsibilities should be fulfilled by the next faculty member in the hierarchy.

The Code should provide clear guidance on interactions on (social) media that respects members' right to extramural freedom of expression.

Federal and Provincial Matters

Your research might be affected by the new federal policy on "sensitive" research areas. The office of the VP-Research is hard at work analyzing the new policy and determining how best to minimize negative impacts to researchers while complying with the policy.

Your ability to recruit graduate students from outside Canada might be affected by new federal requirements. The new cap on study permits issued to international students does not apply to renewals of existing permits, nor to master's or doctoral students.

As I write this, the provincial government has still not given any indication that universities will be permitted to raise tuition for domestic students. This means that McMaster is preparing to cut costs in its next budget cycle.

FACULTY CODE OF CONDUCT

You're no doubt interested the point in the process when you'll get your say. Here's a snapshot of the timeline:

January 2022-August 2023

Drafting Committee (7 faculty members supported by staff) discussed and prepared first draft.

September-November 2023

MUFA Executive and Provost's Council reviewed draft and provided comments.

December 2023

Members of JC compared reviews.

December 2023-February 2024

JC discussing and resolving areas of disagreement, sending items back to Drafting Committee for revision.

February 20-March 5 (tentative)

MUFA membership views and comments on February 2024 Draft.

March 2024

Paying attention to member comments, MUFA Executive decides whether to reopen or conclude revisions.

Future

Possible additional revisions by JC and/or Drafting Committee. Once MUFA Executive and Administration have finished requesting revisions, draft Code will go to SCA, Senate, BoG

Safety on Campus in a Turbulent World

When classes started in September, my colleagues and I who teach Gender Studies classes were acutely aware of the tensions between our academic freedom and the safety of our classrooms. Since October 7, many more of you have experienced this heightened tension in your academic work, while also experiencing distress for your loved ones who are at risk. The University's Statement on Academic Freedom assures us that we have the right to "to teach and to learn unhindered by non-academic constraints". This right is further supported by the Human Rights Tribunal of Ontario. We also have the right to safety in our workplace, and to freedom from violence, harassment, and discrimination. Alongside those rights, we also bear responsibility for our students' safety and freedom to learn. Students want to be confident that their grades will not be affected by their personal identities or stances. Balancing these rights and responsibilities can be challenging at the best of times, and the present moment is far from the best of times. One of the highlights of my job as President is meeting our many new colleagues who have just joined MUFA's ranks. I look forward to seeing many of you—new-comers and longtimers alike—at our upcoming meetings, and to welcoming you to our shared work.

The MUFA Award for Outstanding Service

The purpose of the MUFA Award for Outstanding Service is to provide annual recognition for faculty and professional librarians who have made an outstanding contribution to the mission of the University through the provision of exceptional service to faculty, librarians, staff and/or students.

THE AWARD

Each year there will be a maximum of three awards in the amount of \$2,500.

ELIGIBILITY

The Awards are open to all Full Members of the McMaster University Faculty Association (MUFA).

PROCEDURES

The MUFA Executive will appoint a selection Committee to be drawn from amongst the categories of faculty, librarians, staff and students (undergraduate and graduate).

The Committee shall be comprised of no less than four, and no more than eight members, including the Chair. The MUFA Past President normally serves as Chair and is not counted as the faculty representative.

The Secretary to the Committee will be the MUFA Executive Director.

A quorum for a Committee meeting shall be four members in attendance, including the Chair.

NOMINATIONS

There will be a call for nominations through University and MUFA electronic distribution lists, in the MUFA Newsletter, and on the MUFA webpage.

Nominations must be e-mailed to mufa@mcmaster.ca no later than February 17, 2024.

The nomination must include a summary of not more than 750 words highlighting the candidate's accomplishments.

Each nomination must be supported by a minimum of two and not more than four reference letters. The reference letters must be e-mailed or mailed to MUFA, either through the nominator or directly from the reference. Reference letters should not exceed 500 words. The position and contact information for the nominator and all references must be clearly indicated.

The Committee will review the nominations and will make the final decision regarding the selection of award recipients. Some of the factors considered by the Committee will include: enhancement of the reputation of McMaster University; provision of excellent service; demonstrated innovation; breadth and depth of impact the enhancement of

student success the ability to establish and maintain effective and harmonius working relationships; evident acceptance of diversity and inclusivity at McMaster; strength and diversity of supporting references.

The faculty/librarians selected to receive the awards will be invited to attend a special reception normally held in conjunction with the MUFA Annual General Meeting and will be presented with their awards at that time. Pictures of the individual recipients and a brief summary of the rationale for their award will be published in the MUFA Newsletter and on the MUFA webpage.

Each eligible faculty/librarian who was nominated for an award will receive a letter of commendation from the MUFA President.

MUFA faculty/librarians are not eligible for the President's Awards for Outstanding Service, awarded by the President of McMaster University

Those holding academic administrative appointments with the rank of Assistant Dean or higher in the current academic year are not eligible for the Award
